

A mother and her four young children, recently homeless and forced to sleep in their car, found hope as we coordinated transportation to a safe, welcoming family member's home out of state.

Another client and her young daughter, escaping an abusive relationship, were living in unsafe conditions when we stepped in to secure a new apartment and replace damaged belongings.

And when a young mother and her child were assaulted by a family member, we arranged transport to an available shelter outside the area when local options were exhausted.

These examples underscore the essential role of our newly established Crisis Case Management program, which reached capacity immediately upon launching. When crisis strikes,

whether through sudden homelessness, unsafe housing, or dangerous living situations, our program steps in to meet urgent needs, offering a lifeline that prevents escalation and fosters a path to stability. By securing emergency housing, covering initial rent, or providing safe transport, Crisis Case Management directly addresses gaps that vulnerable individuals and families cannot manage alone. The program's impact is not just immediate relief; it's about restoring safety and empowering people to rebuild their lives—one critical step at a time.





St. Joseph House of Hospitality exists because we understand that older unsheltered men in our region have few options.

Many who come to us carry decades of unresolved trauma. Unlearning patterns of neglect, despair and dysfunctional coping mechanisms takes time and in-depth support. We ensure both.

But our work goes far beyond shelter.

Newly created, our Life Enrichment Program is a pivotal step in helping our residents reclaim ownership of their lives and surroundings. The men we serve are learning to take pride in their home. They're actively involved in maintaining and beautifying their living spaces, which fosters deeper connection. This sense of ownership is vital—it nurtures responsibility and self-worth.

But that's just the beginning. The Life Enrichment Program is also about skill building. Residents are gaining practical skills that not only enhance their everyday lives but also equip them for future opportunities. Whether it's learning new trades, developing creative talents, or improving personal care, these skills are stepping stones toward independence – the ultimate goal for each man.





Annually, approximately 43 percent of our budget comes from individuals, foundations, and corporations. We rely on these funds to provide high standards of needed care. We are grateful for trust in our stewardship and for the endorsement of our mission.
